## **Lessons from National Women Physicians Day**

Dear Mighty Team,

I would like to share closing remarks from the hospital's recent National Women Physicians Day (recognized Feb. 3) event:

"I thought it might be helpful to speak briefly about the TEN RULE in psychology and another framework involving the number 10. Now, I'm not a psychologist, or a psychiatrist, I am a pediatric emergency medicine physician and chief medical officer and probably like you, I have struggled with decisions when trying to balance work and home.

Life can be tricky...let's think about this: Ten percent of life is made up of what happens to you and 90 percent of life is decided by how you react to that 10 percent thrown at you!

So, we have virtually no control over 10 percent, but we do have some control over 90 percent!

Let's tap into a framework set forth by author Suzy Welch. The framework is simple and is called 10-10-10. When faced with a situation, a dilemma, a decision to make and how to react, ask yourself, "How will I feel about this decision in 10 minutes... in 10 months... and in 10 years?" In making a decision proactively, consider the options in the immediate present, the near future and the distant future.

Let me share a real-life situation and of application of this framework. Just this past weekend, I was at my daughter's college, attending her women's ice hockey game. I was speaking with the other co-captain's mom (Liz) about next weekend when we'll honor the graduating seniors. Both our daughters are captains and seniors, and both have moms who are physicians.

Liz confided that at first, she felt conflicted about what to do about next weekend. There was a pause... and then she shared that she wouldn't be at senior night because she would be attending a board meeting for her national medical society. She felt if she wasn't there as promised months earlier, that she might lose the opportunity to be the next president of her discipline's academy (a field in medicine comprised predominantly of male physicians, and she shared that there has never been a female president).

Reading Suzy Welch's book, Liz thought about this difficult decision and how she would feel about it in 10 mins, 10 months and 10 years. She also shared this thought process with her daughter, Abby (who by the way, is applying to medical school). Her daughter said, "Mom, sure I am gonna miss you at senior night, but you're a trailblazer and I am so proud of you."

Liz said she wished she could be at the school that night, but she made her decision based on the impact her presence would have at that national meeting and future meetings, and paving the way for her daughter and other daughters by she herself, very soon serving in a leadership role so that future female physicians could attend a function like their child's senior night without being judged or criticized.

So, 10-10-10. When faced with a difficult dilemma, how might we feel about our decision in 10 minutes, 10 months and in 10 years. I think for my friend Liz, and her daughter Abby, and many others, the feeling will be a good one! Some decisions are tougher than others. With the framework of 10-10-10, maybe some will be a little less difficult."

Congratulations on the positive impact that each and every one of you is making every day!

The libraries also promote the Yale New Haven Health care signature initiative by fostering an atmosphere of innovation, collaboration, cooperation and life-long learning in support of an academic health network. Each library is open to YNHHS faculty, students, staff and affiliates and provide easy access to thousands of electronic journals, books and videos.

Each library provides access to several shared search engines including CINAHL, ClinicalKey for Nursing and ClinicaKey for physicians, OVID Medline and PubMed. These resources allow staff to easily search for and access journal articles. The libraries also provide access to individual resources that meet the need of unique service lines at each delivery network.

# Yale New Haven Health nationally recognized for health-related social needs screening

In recent years, Yale New Haven Health launched an initiative to help screen patients for non-medical issues that can directly affect health, such as financial difficulties, inadequate housing and lack of reliable transportation. Since then, a team has refined and expanded its processes for gathering this health-related social needs (HRSN) information to help connect patients with services that can assist them.

The health system recently received national recognition for this work, with an article in The Joint Commission's November *Journal on Quality and Safety*. Staff with YNHHS' Population Health and Clinical Integration department and Office of Health Equity and Community Impact, along with Yale School of Medicine collaborated to submit the article.

The processes the health system developed include a standard questionnaire. Patients choose whether to answer the questions, which cover four core HRSNs: food insecurity, medical and nonmedical transportation, financial strain and housing stability. A workflow in Epic guides clinicians in asking the questions and entering information into participating patients' electronic medical records. A social drivers of health Care Pathway has also been developed for care team members to access resources if a patient screens positive.

Since implementing the HRSN program, YNHHS' annual screening rate for all active ambulatory patients increased from 0.4 percent to 15.9 percent. Of the patients screened, 10.7 percent had at least one health-related social need. The annual screening rate for inpatients grew from zero to 66 percentage points. The most common health-related social need in both settings was financial difficulties, followed closely by food insecurity.

Epic also helps specify whether patients are experiencing low- moderate- or high-risk HRSNs, which determines the amount and type of assistance they receive. That assistance may range from providing patients with low-risk HRSNs information about community resources such as local food pantries, to helping patients with high-risk HRSN apply for food assistance or find stable housing.

## **Safety Matters**

The importance of reporting near miss events and Great Catches

The Great Catch Program fosters an increasing culture of safety by encouraging the recognition and reporting of risk before a patient is harmed. Reporting of near miss safety events, or Great Catches, provides us with an opportunity to learn and prepares us to respond confidently to future events. Staff need to feel safe to continue to report these events and we need to create an environment of trust. Near miss reporting and analysis offers several advantages:

- It provides information about unplanned, last strong or early barrier catches.
- Near miss events occur far more frequently which provides actionable data for causal review and corrective actions to prevent future serious events.

Encourage colleagues and team members to report near miss events and Great Catches into SAFER. Discuss what could have gone wrong and how to prevent it in the future and celebrate team members demonstrating CHAMP behaviors.
