- Restructuring Risk Management, PPEC and Department Quality Committees (Peer Review): Triggers and Pediatrics (possibly forming a "DQC" and now representation on PPEC).
- DQC (Department Quality Committee) survey completed by Dr. Nidhi Shah and Theresa Conciatori. Dr. Shah presented at the Nov. 10 MEC (shared an understanding of what leadership does now for Departmental Peer Review and Quality).

- DNOR (Delivery Network Operating Report)
   Update: Clinical Pathways over 350 pathways are now available.
- OPPE/FPPE (follow-up): Theresa Zinck-Lederer, executive director Medical Staff Services, has offered to speak the MEC meeting in December or January on both topics.
- Clinical Observer (follow up): Since our last MEC, we have engaged with Stacey Green who updated us on advances in Volunteer Services/the Auxiliary. Stacey and I worked on developing a program for students in the summer that would provide a structure for students to get exposure to the hospital and get some hands-on experience. The proposal is under review. It would be a Greenwich Hospital/YNHHS program complying with the specifics of the Clinical Observer Policy reviewed last month.
- Respiratory Viruses: This winter promises to be a difficult one between COVID, Influenza and RSV. Yale New Haven Children's Hospital has had to convert units to Pediatric specific units to accommodate the increase in RSV admissions: children are admitted with respiratory distress and hypoxia and the most at risk are infants less than 6 months (and adults over 65 years old, also). Please get your flu vaccine (mandatory by Dec. 1). Influenza A is already among us.
- Consults: A concern was brought to the attention of medical staff leadership related to a specialist on call not receiving consults while he/she was on call (but rather another physician in the same specialty was called). An in-depth review was performed during the time frame in question and was reported out in the November Department of Medicine Peer Review Chair's Report. This concern could not be substantiated.

### Serious Safety Event/DPH Reportable/Medical Staff Professionalism Trends

- AMAH (Airway Management After Hours)
   Initiative: The Respiratory Therapy team (led by Gabby Sandaire) will once again have the opportunity to train in the OR and refresh their intubation technique (thank you to RT, Anesthesia and the OR team).
- TART (Threatened Airway Response Team): We are working to make sure we have appropriate responses and resources available.

- Handoffs/Doing Physical Exams/Time Outs/
  Compliance/Corporate Objectives: We continue
  to identify opportunities for improvement related
  to appropriate and thoughtful handoffs and time
  outs. Especially concerning appears to be a trend in
  less-than-optimal physical exams and appropriate
  documentation, particularly when there is a change
  in status in a patient. PPEC will be following this and
  providing timely feedback to support our medical staff
  and our patients.
- PPEC (Professional Practice Evaluation Committee)/Surgical Governance Committee):
   Dr. Nidhi Shah presented an overview of the refresh and progress of our new Greenwich Hospital PPEC.
- SERC (Significant Event Review Committee for Greenwich Hospital): Dr. Kirsten Lawrence presented an update at a System Quality and Safety Meeting
- Practitioner Concerns: The October edition of
   Medical Staff News provided an update and summary
   on HAVEN (Health Assistance InterVention
   Education Network).
- Infusions at Long Ridge/Informed Consent: During
  a mock survey, we were cited for not having proof of
  informed consents for infusions (biologics) at Long
  Ridge. We obtained a list of the infusions (thank you
  Jim Duffy) and met with Kathleen Cody and Jessie
  Riemer from Accreditation/Licensure and Regulatory
  to develop the SBAR (Situation, Background,
  Assessment, Response/Recommendation) below.

### Greenwich Hospital Consent for Infusion SBAR 11/7/22

**S:** Some of our patients may be receiving continuous infusions (biologics) without evidence of a Consent for the Infusion being documented in the medical record.

**B:** It is a Joint Commission Requirement that patients receiving an infusion be appropriately consented.

A: After review of our Consent for Procedures and Treatment Policy and the Joint Commission recommendation we found an opportunity for improvement to obtain consent for all infusions outlined in the Greenwich Hospital Medical Staff Policy: Surgery and Other Procedures Requiring Informed Consent both at the main campus for Greenwich Hospital and at our outpatient sites (Holly Hill, Bendheim, West Putnam and Long Ridge)

R: The expectation is for our providers (Responsible Practitioner in the attached policy) to obtain Informed Consent for all continuous infusions and have it documented in the medical record. The Consent will be considered active for one year and after that time the process will need to be repeated if the infusion is to be continued. If there is a change in treatment, a new consent must be obtained.

**President's Report:** Town Hall meetings have begun. They are initially focusing on the Employee Engagement Survey results and the areas on which hospital leadership should focus efforts. Employee/Staff Safety rose to the TOP!

## The importance of dreaming big – introducing the Martin Luther King Jr., Scholarship

It is with a great sense of pride and purpose that as a member of our Medical Staff Diversity, Equity and Inclusion Council (DEI-MS) at Greenwich Hospital, I can participate in the development and initiative of the Martin Luther King Jr. Community Service Awards at Greenwich Hospital. These awards have been presented at Yale New Haven Hospital to high school students for many years. Spike Lipschutz, MD, brought it to our attention, and we immediately wished to bring these awards to our community. Also, I felt personally obliged to bring the MLK Jr. awards to fruition in our community appreciating the potential impact on many levels.

Allow me to share that I was one of the first recipients of the Rosa Parks Scholarship as a graduating high school student in my hometown. My mother gave me an article from the *Detroit News* announcing this \$2,500 scholarship. I had to write an essay stating what Rosa Parks and her Civil Rights cause had meant to me – the deadline was the following day! I recall how I stayed up that night, pondering and expressing what she stood for and how I had profound appreciation for her as a woman and civil rights activist. It was that evening, when I realized that I had the ability to create my own opportunities. Opportunities evolved as I actively shared my goals and dreams not knowing who was listening, would help, and support me.

This scholarship changed the trajectory of my life. I was originally going to attend the more affordable in-town state university, but my hope and desire was to participate in the BS-MD program at Howard University in Washington, D.C. Knowing my true goal, my mother gave me \$100 and a one-way bus ticket to Washington, D.C., and I arrived on the last day for class registration. I learned of winning the Rosa Parks scholarship after a couple of weeks at Howard University. It financed my first semester and I was able to secure academic scholarships thereafter.

The importance of knowing and appreciating the sacrifices of those who came before you cannot be over emphasized. My concern is that Martin Luther King Jr.'s birthday will become just another day to extend a long weekend for

personal enjoyment without appreciating what it truly represents and what it took to make it a holiday.

Again, I can extrapolate from personal experiences what a huge effort it was to make King's birthday a holiday. As a teenager, I recall attending a Stevie Wonder concert and the final song was "Happy Birthday." Everyone continued to sing that song with our lighters flickering as we walked to our cars. That was an impactful and powerful moment, and the words of that song remain meaningful.

If you dream does not seem insurmountable, and you think you can achieve it alone, then you are not dreaming big enough! Martin Luther King Jr. exemplifies what it means to dream big, to sacrifice for one's dream, and to gather masses of people in pursuit of a shared truth and vision. How do we continue to shine light on and keep the dream of MLK Jr. alive?

Giving local high school students the opportunity to win a monetary award for their community service and reflecting on what MLK Jr. means to them is a purposeful way to give back. The more applicants for the awards, the more alive the MLK Jr. dream will persist within young people. We hope to present \$1,000 scholarships to public high school students in Greenwich and Stamford, CT and Port Chester, New York. (More information on the scholarship program to be announced.)
